SDG & SDGG	30 Days	Defects. E.g. hole in dumbbell, sharp edges	paint peeling, rust, loose heads if dropped
SDN & SDNB	30 Days	Impurities in coating such as bubbles	Rips and tears, broken core as a result of dropping.
SDC & SDCG	30 Days	Peeling (if not a result of abuse)	Dents or dings as a result of use.
SDR	Limited Life	Everything is covered unless evidence of abuse. E.g. cuts or bent handles.	Warranty is void if signs of abuse are present. IE bent handles wear deemed excess or as a result of misuse.
RP & RPG	30 Days	Defects such as hole filler in plate	Paint peeling, rust, cracks and signs of abuse.
OP & OPG	30 Days	Defects such as hole filler in plate	Paint peeling, rust, cracks and signs of abuse.
REG. SETS	30 Days	Plates (same as OP/RP) Bars (same as RB)	Using excessive weight on bar or other signs of abuse.
OLY. SETS	30 Days	Plates (same as OP/RP) Bars (same as RB)	Using excessive weight on bar or other signs of abuse.
MACHINE PLATES & WEIGHT STACKS	30 Days	Same as RP, OP and SDG. Stacks not lining up properly.	Using other mfg's components for assembly. IE selector shafts, top plates and keys.
HANDLES (SDA, SDH)	30 Days	Bubbled or Peeling chrome. Oversized ends. Rust if from original opening of SDAB box	Bent as a result of excessive weight or other signs of abuse.
REG. BARS	30 Days	Bubbled or Peeling chrome. Oversized ends. Rust if from original opening of RBB box	Bent as a result of excessive weight or other signs of abuse.
OLY. BARS	30 Days	Bubbled or Peeling chrome. Oversized ends. Rust if from original opening of OBB box	Bent as a result of excessive weight or other signs of abuse. Exception: OB-86PB, PE limited life barring signs of abuse.
COLLARS	30 Days	CAP collars: 30 days Others: subject to Mfg's warranty coverage	American Collars by Mfg. Warranty. Consumer to contact supplier directly
FM & FMG	2 Yr. Frame	Covers welds, tubing unless signs of abuse are present such as excessive weight being used.	Pads, rollers, bolts, nuts. Unless missing or damaged in original box.
RK	30 Days	Covers welds, tubing unless signs of abuse are present such as excessive weight being used.	Bolts, nuts and rubber pieces. Unless missing or damaged in original box.
SM-	Limited Life	As outlined in Phys-X warranty guide	
HH-	30 Days	Defects in rubber, plastics.	Damaged caused by misuse
PROSTYLES	Limited 90 Days	<u>Please read warranty information at bottom of page.</u>	
MA & MAT	30 Days	Defects in rubber or plastic such as bubbles. Leather goods to be covered by US mfg	Warranty voided if signs of abuse or misuse are present.
MB, MBG & MBT	30 Days	Bubbled or Peeling chrome. Frozen swivels. Rust if from original opening of MBB box	Signs of abuse. Dropping, rust, etc.

PROSTYLE WARRANTY:

Prostyles with RP & RPG = No warranty on assembly or parts.

Prostyles with RM & RMG = Limited lifetime applies to all components. Plates, Handles, Caps and Assembling. Excluded are spinning plates (if bolt is still tight). Chipped paint or scratches, unless damaged during shipping. Bent handles are not covered as this is a high indicator of dropping or other abuse. Cracked plates or handles are not covered as this is another indication of abuse.

CAP will not be held responsible for transportation or labor costs associated with returning merchandise. All goods must be shipped prepaid to a CAP facility for inspection. Any collect or 3rd party shipments will be refused. CAP is not responsible for any damages that may occur during the products transportation to or from our facilities. Upon inspection if the product(s) are deemed defective, CAP reserves the right to repair or replace those goods at our discretion. Any repaired or replaced merchandise will be shipped prepaid by a CAP approved carrier. In the event that the goods are not defective; the customer will be fully responsible for the pickup of the product from our DC at the customer's expense. The customer must assign and prepay the carrier. Any returns not picked up within 30 days of their receipt at a CAP facility may be destroyed or assessed a storage fee of up \$50 per day.
